

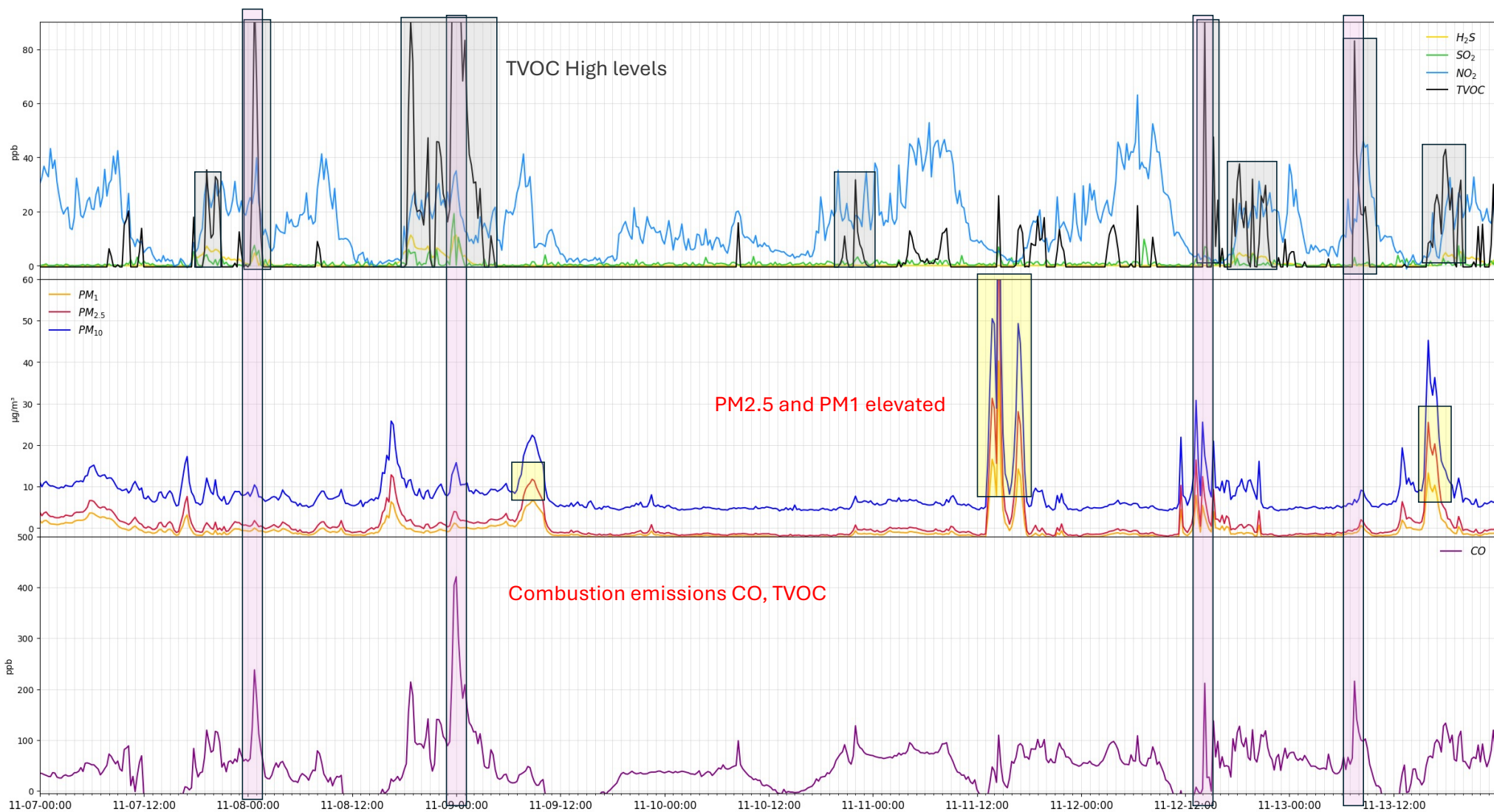

Disclaimer

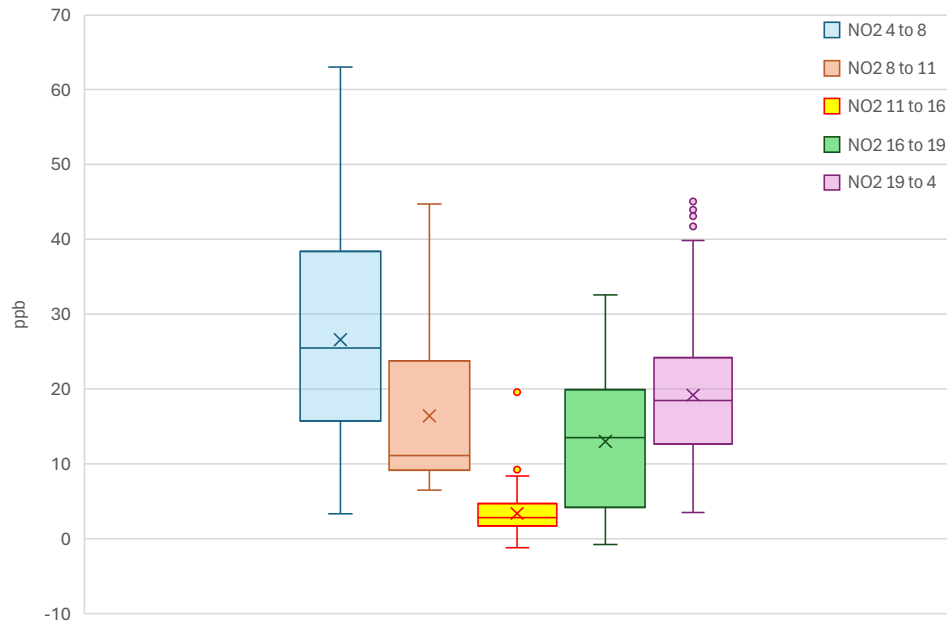

At the same time, most of the sensors are subject to QA/QC procedures and are calibrated and evaluated against official regulatory monitors.



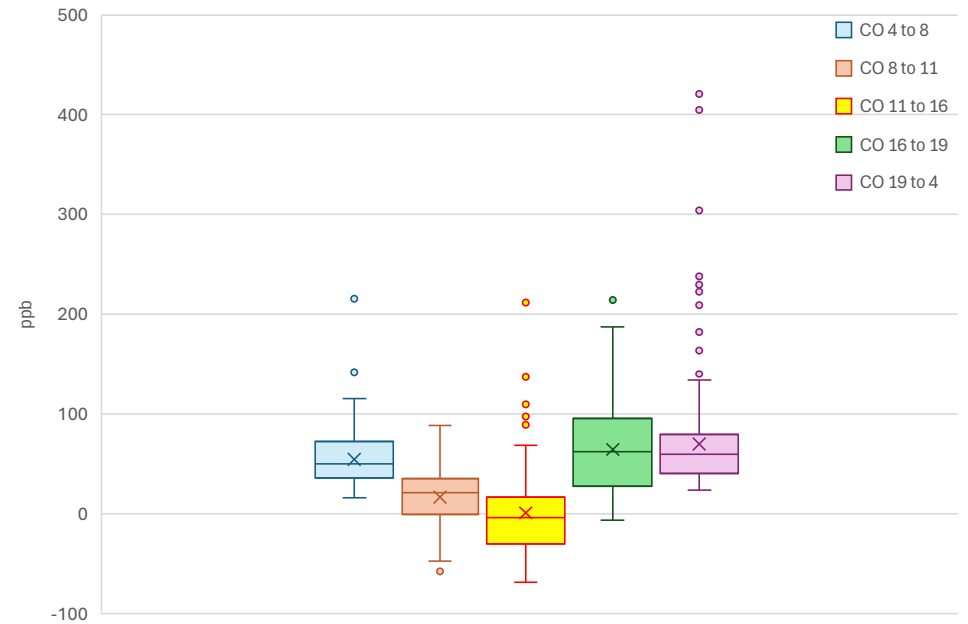

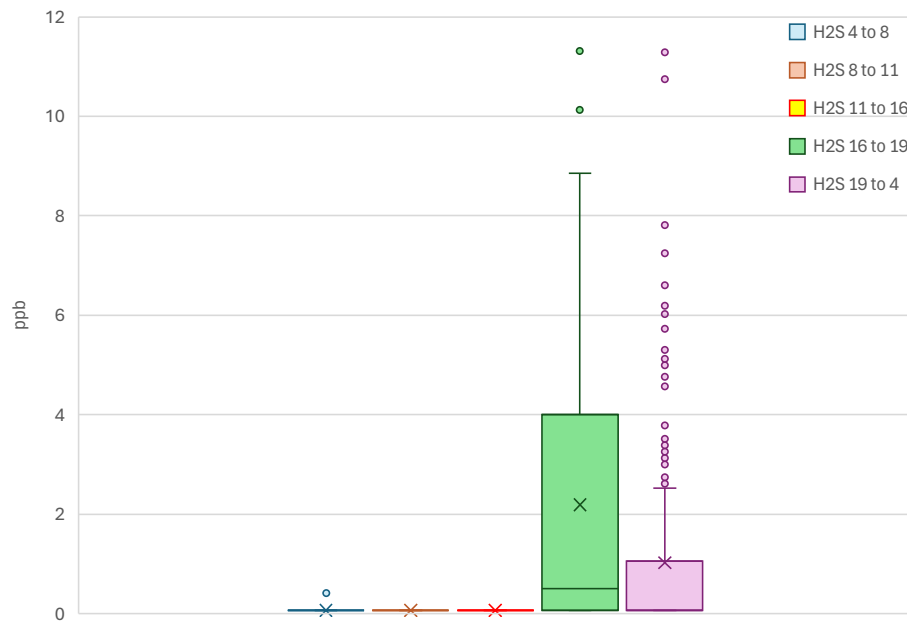

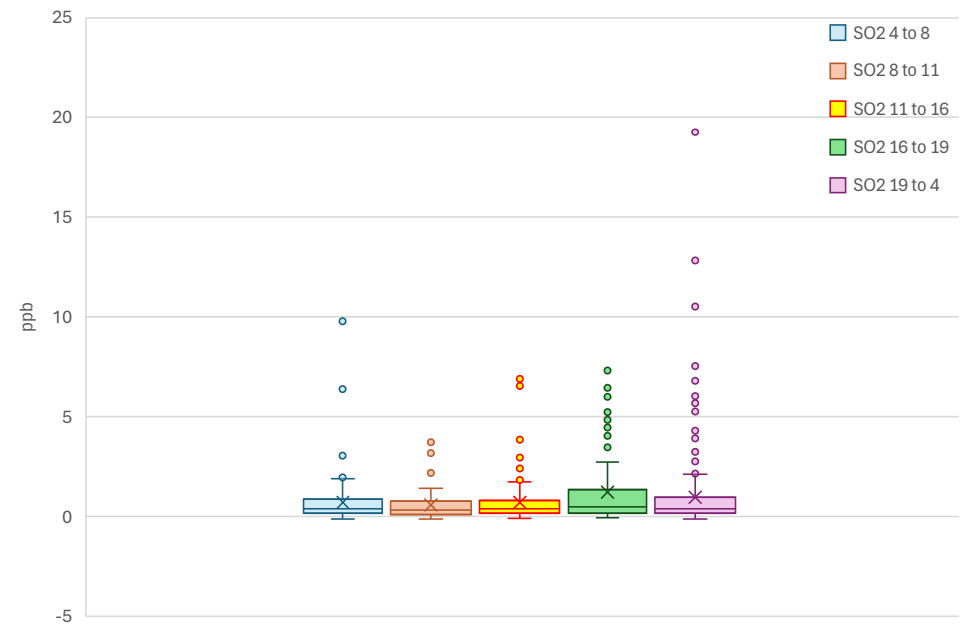

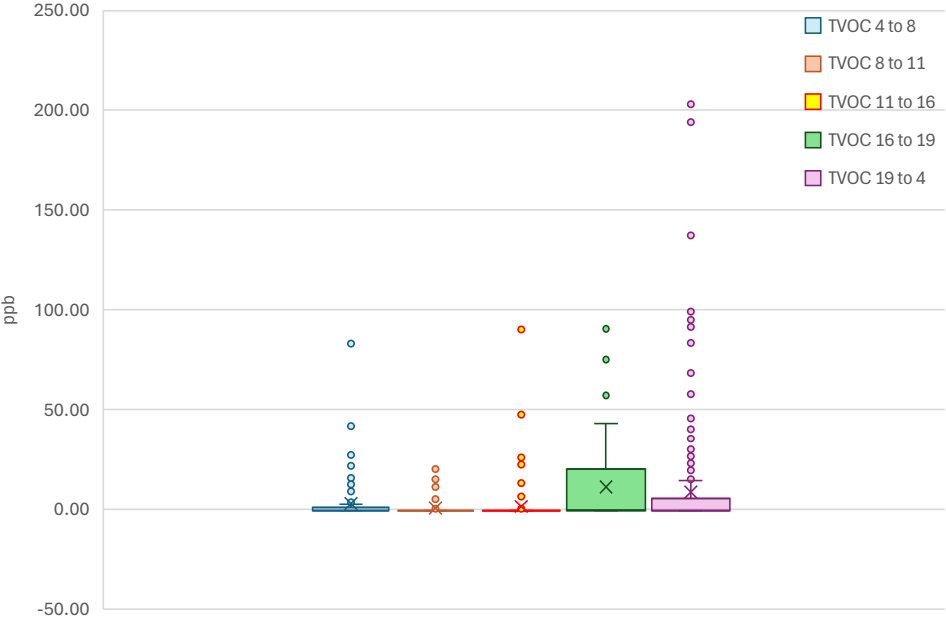

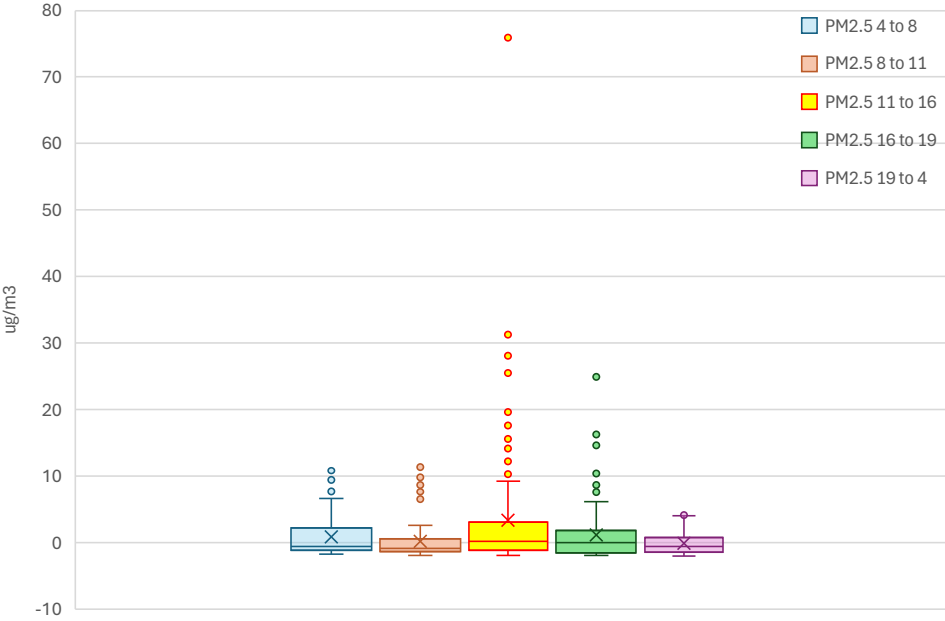

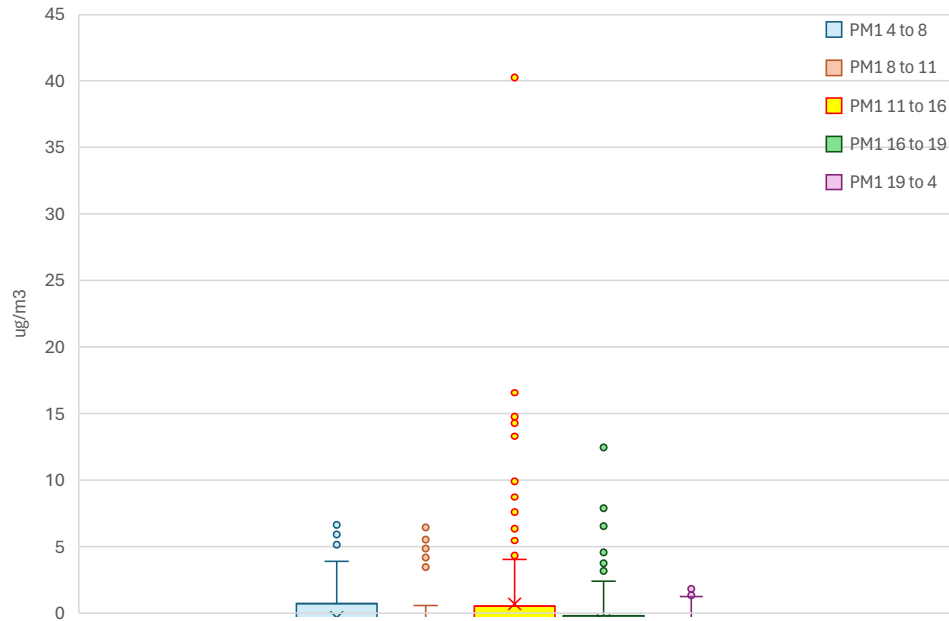

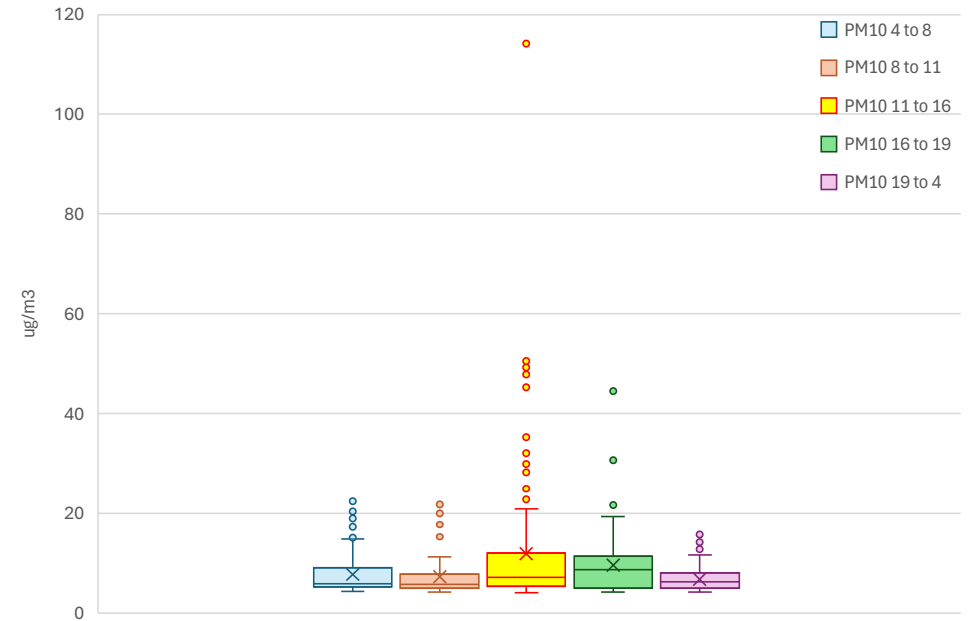
Hourly concentration distribution

PM1 hourly distribution



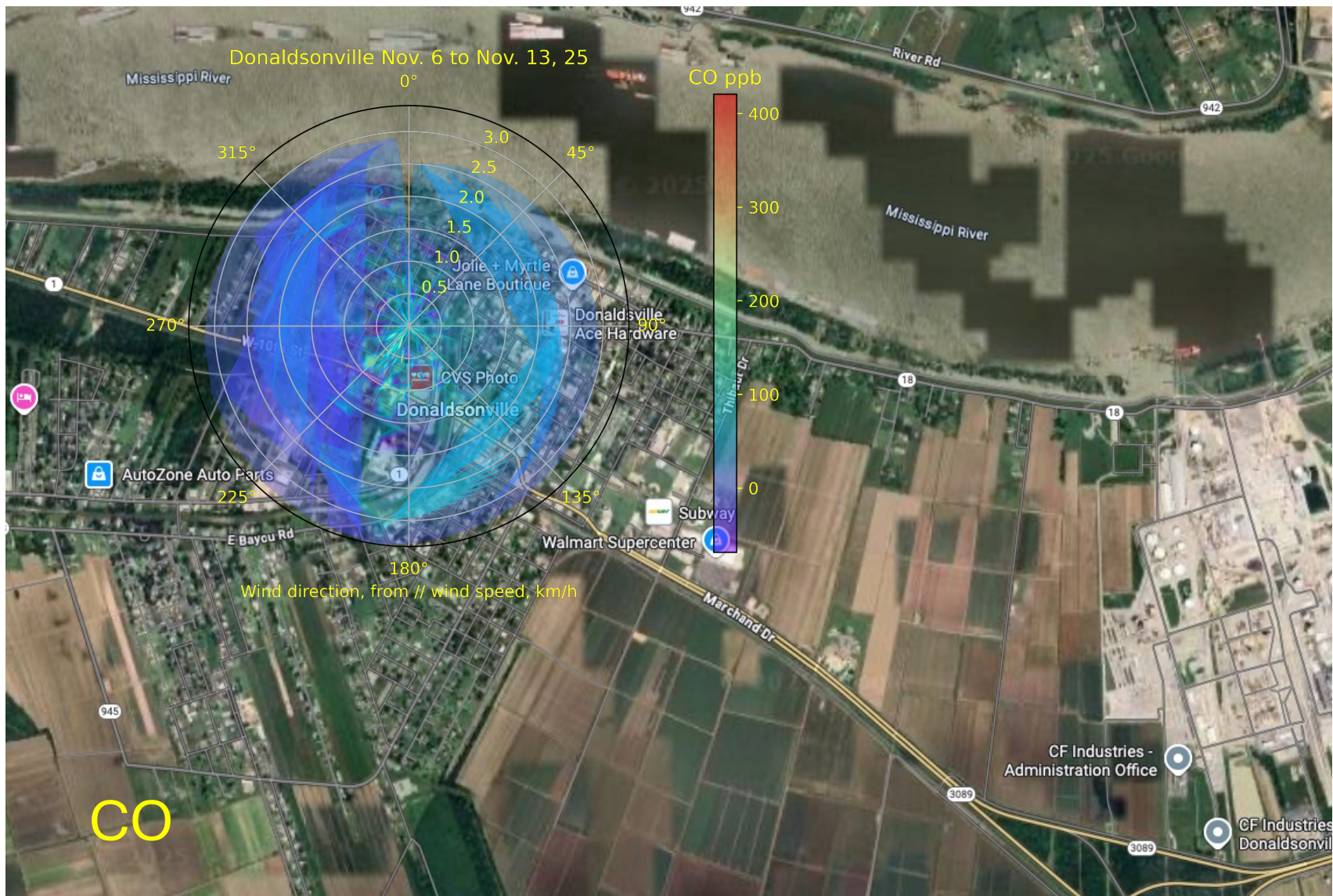

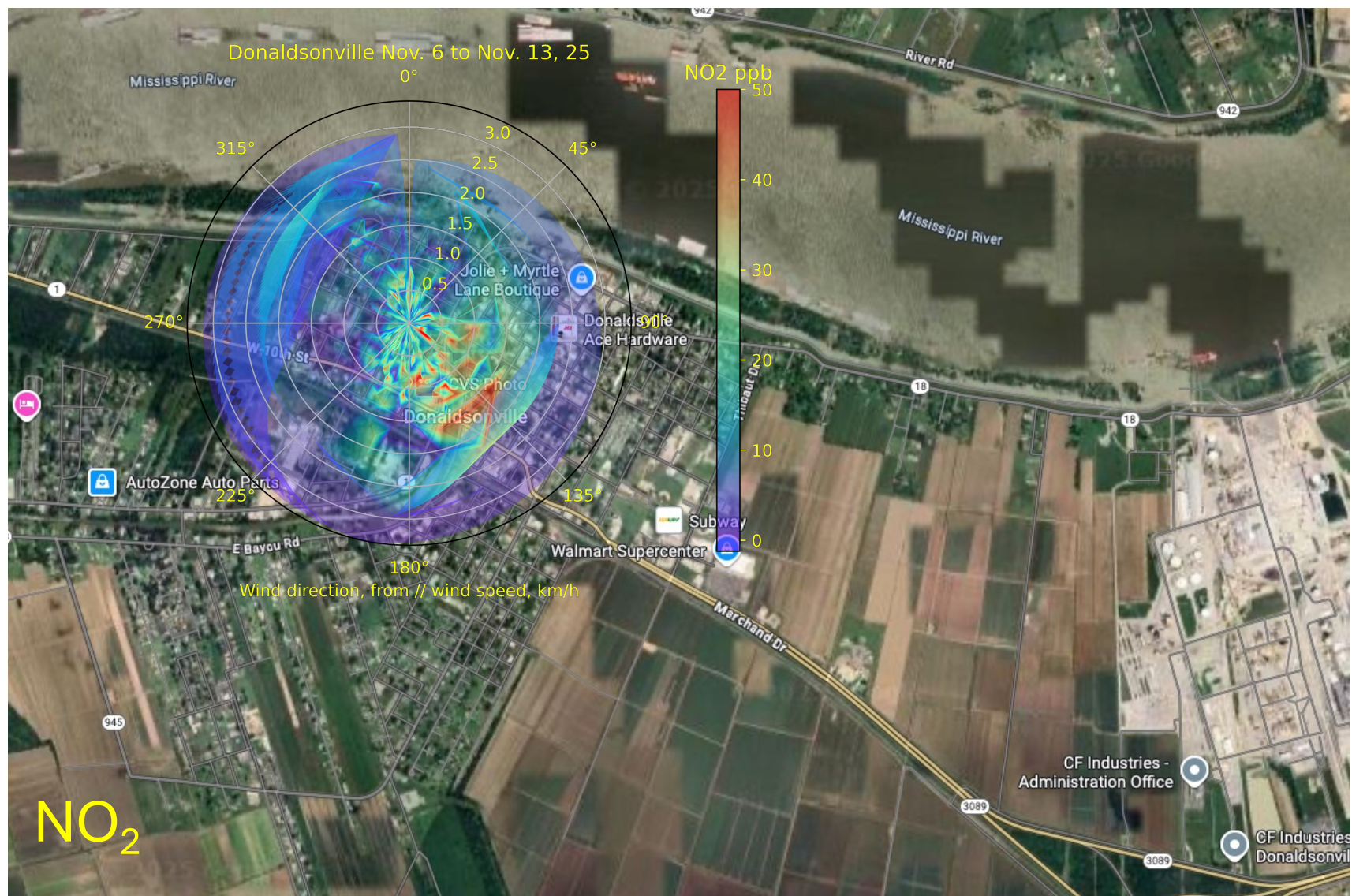

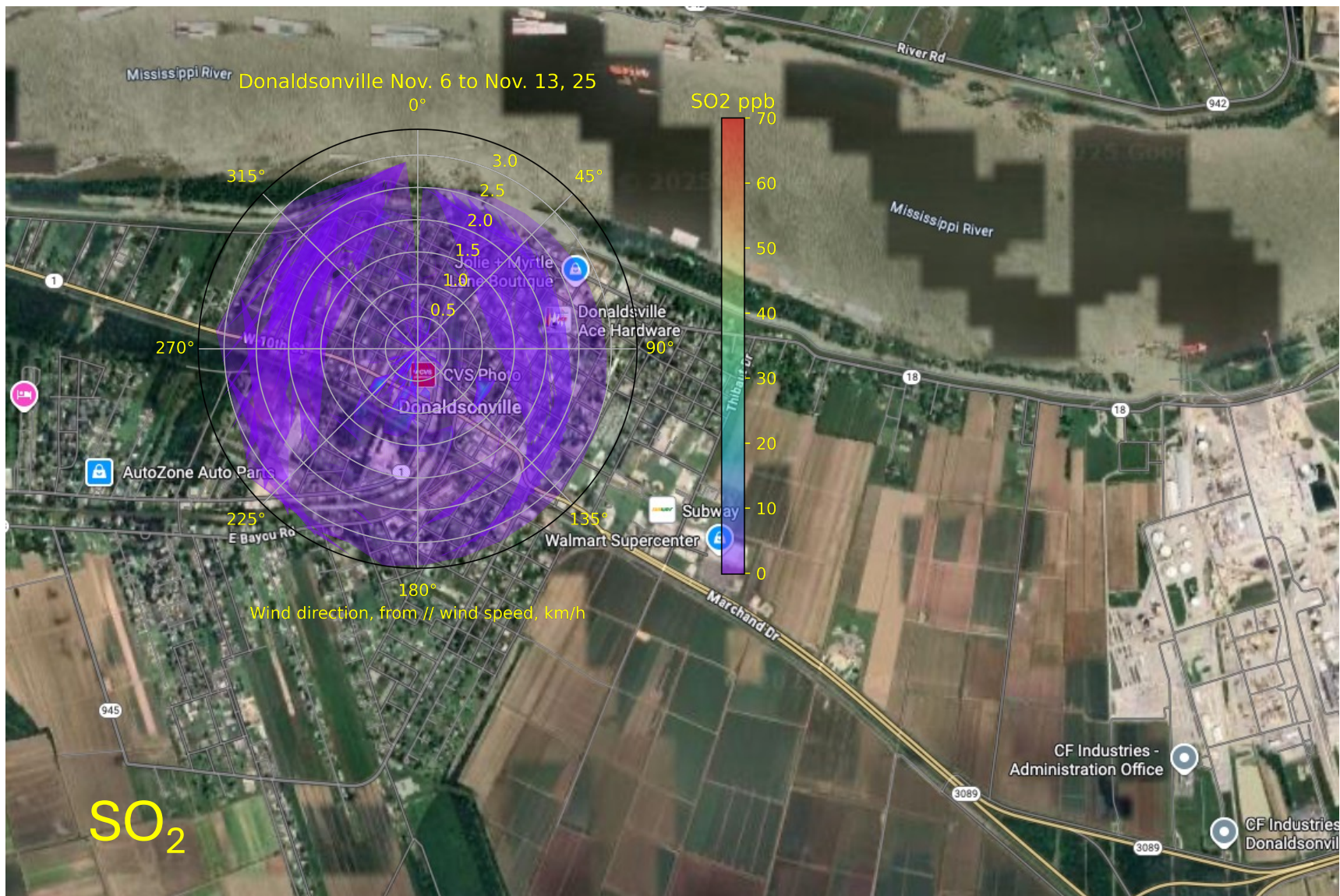

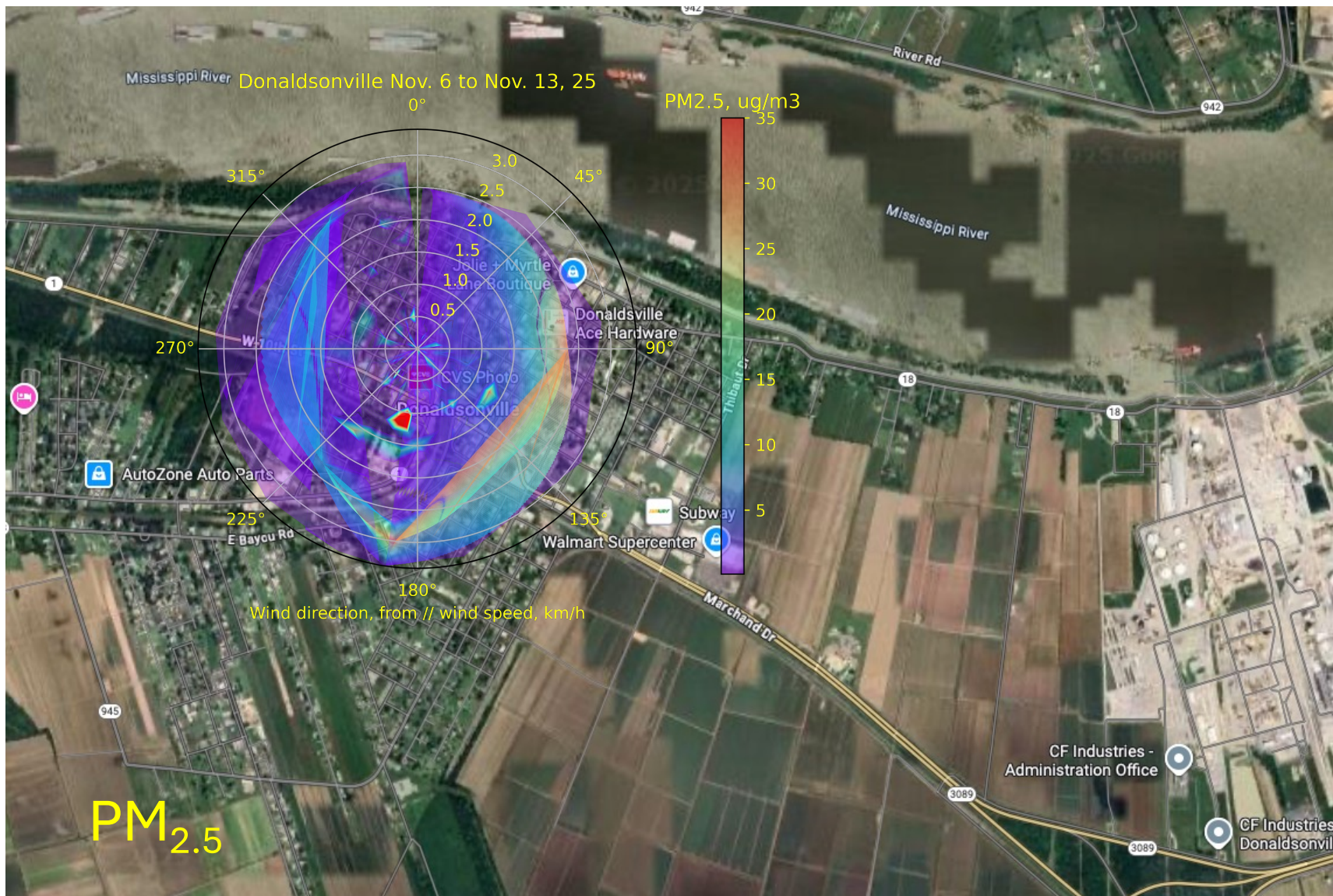


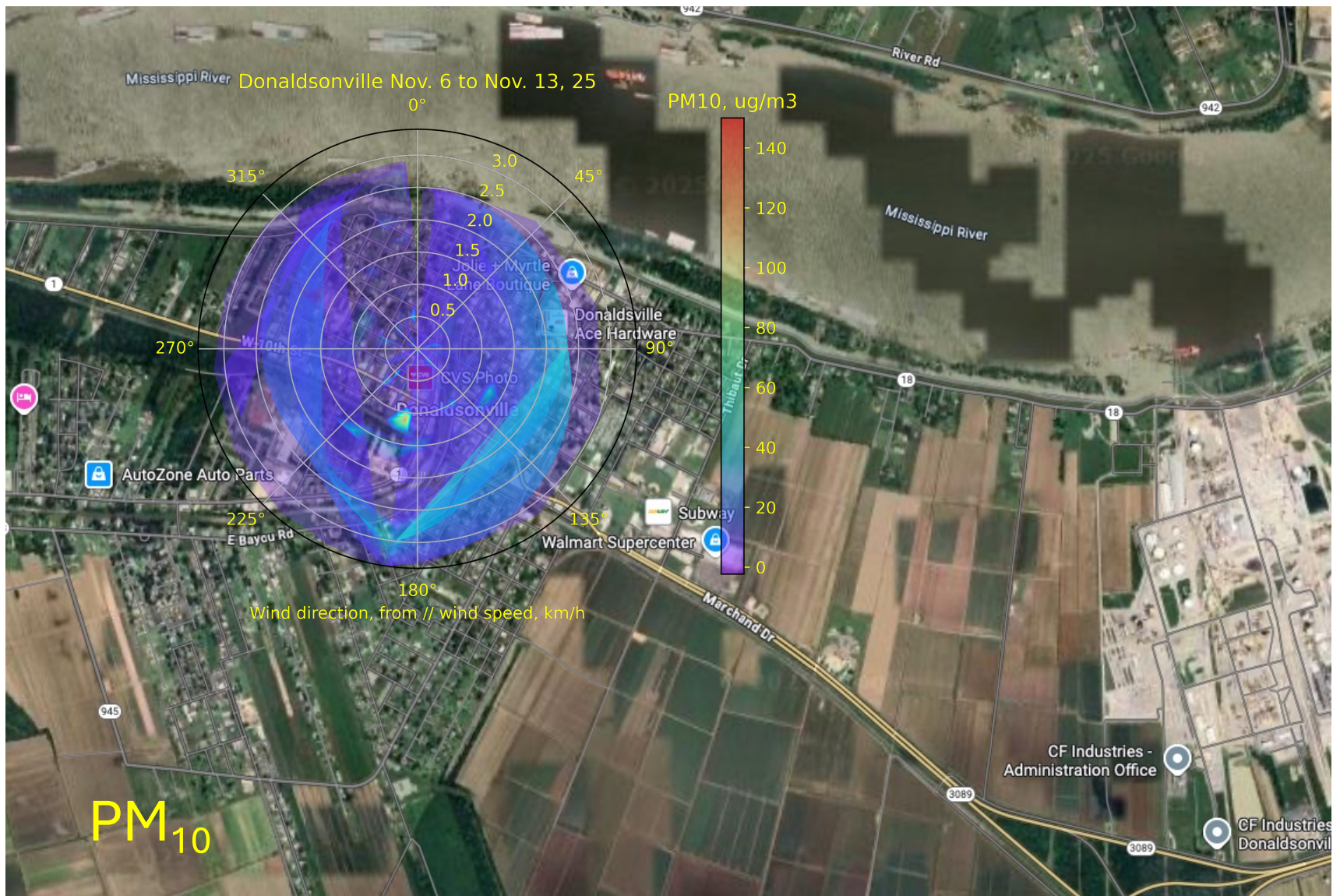














Donaldsonville POD 11/07- 11/13
