

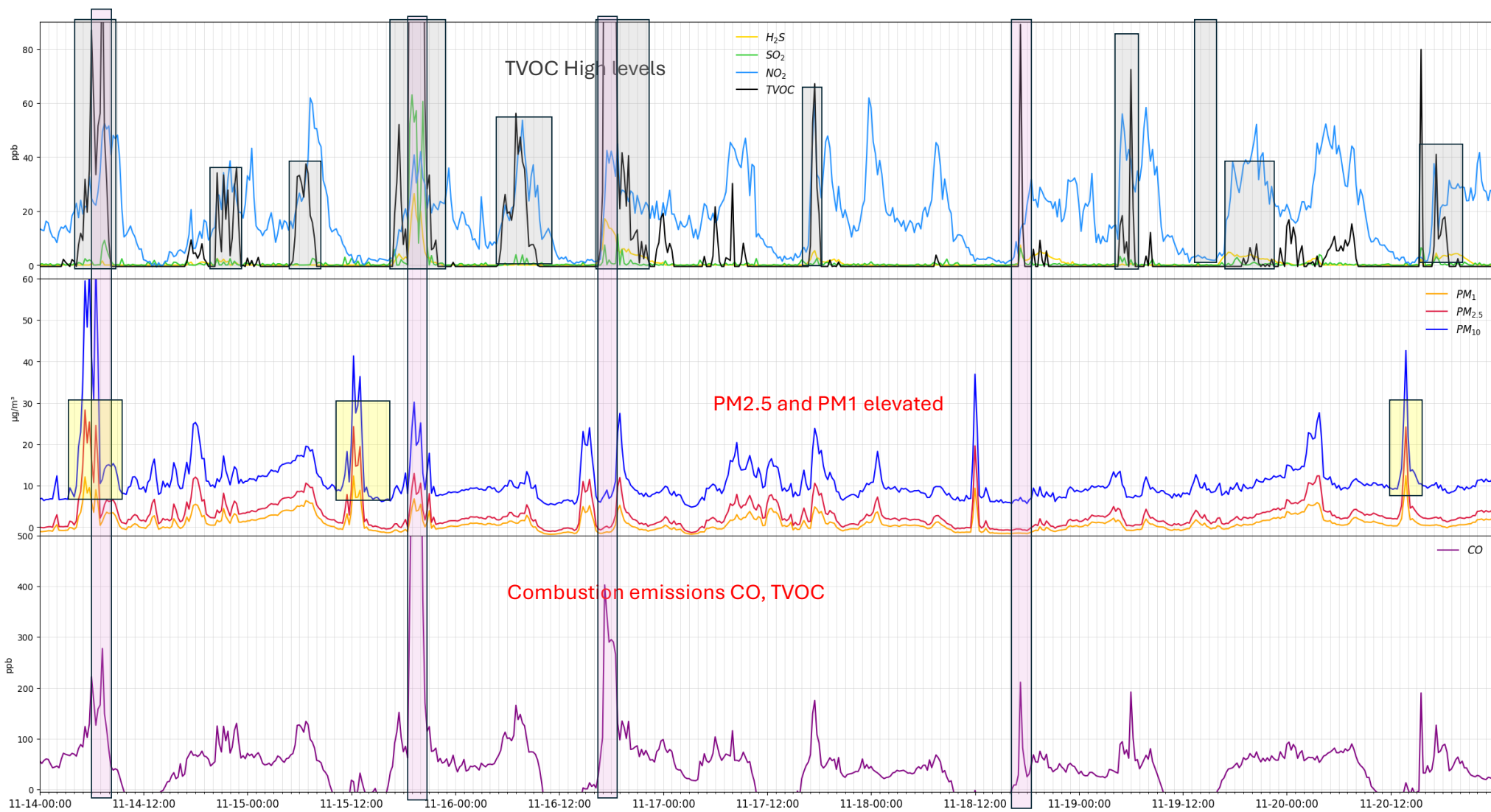

Disclaimer

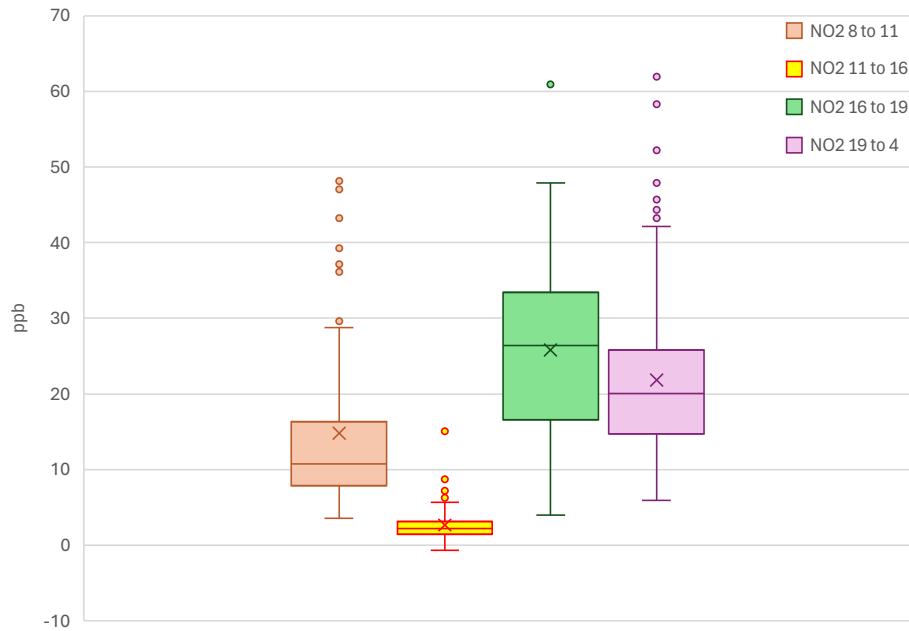

At the same time, most of the sensors are subject to QA/QC procedures and are calibrated and evaluated against official regulatory monitors.



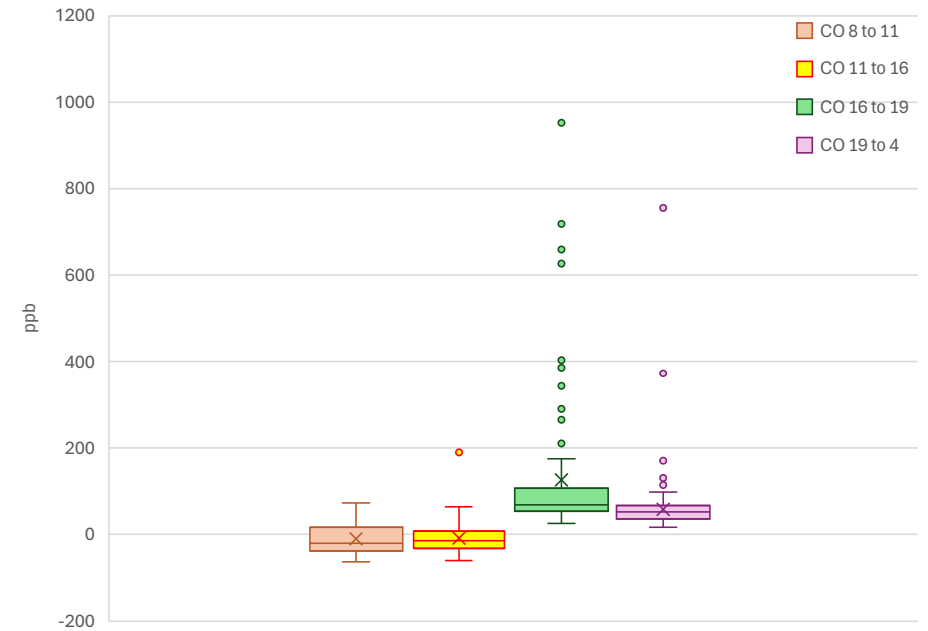

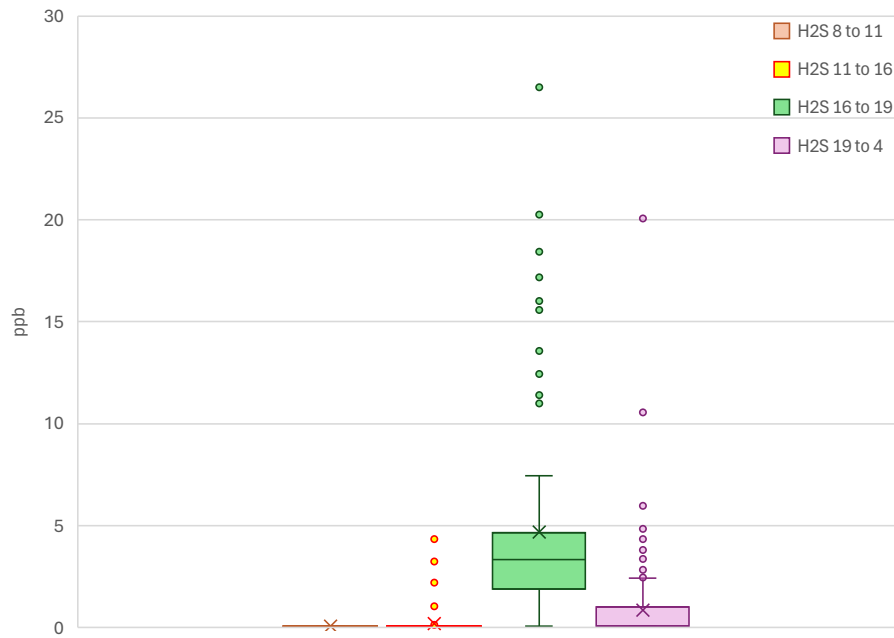

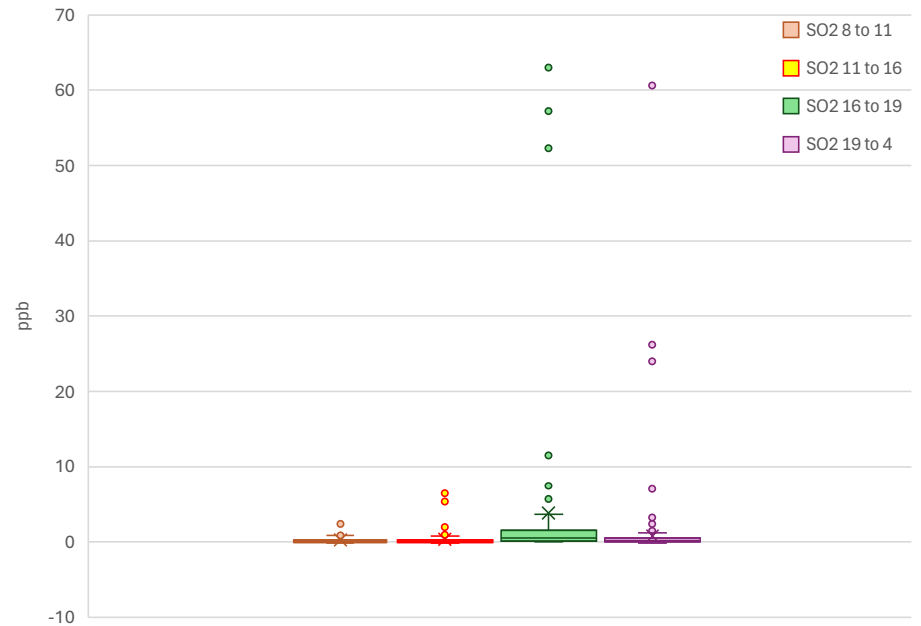

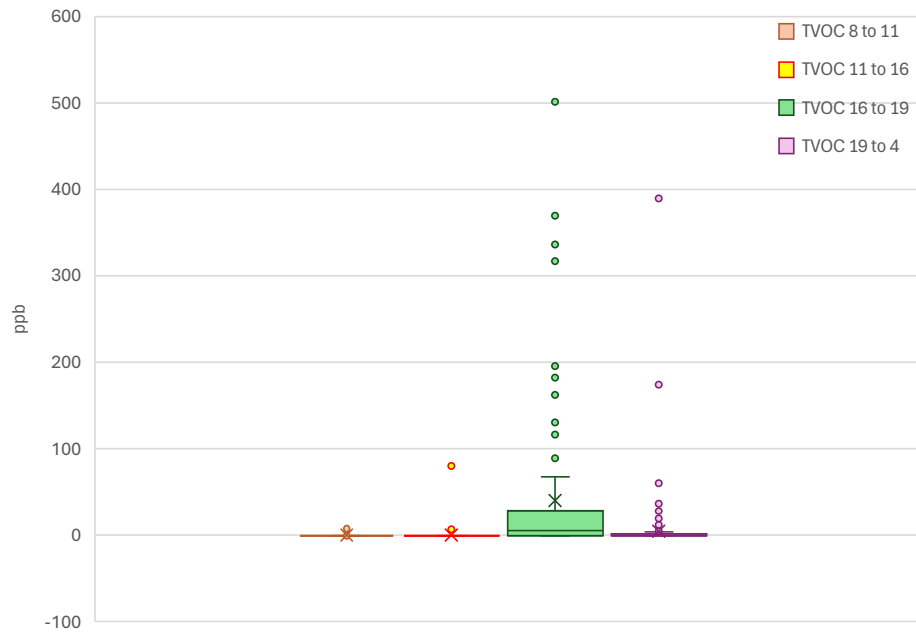

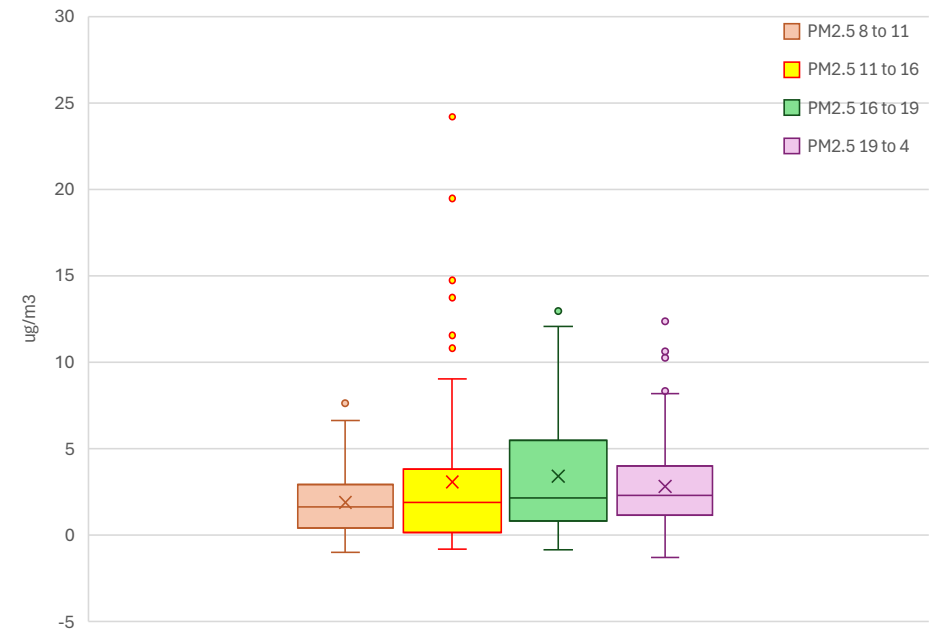

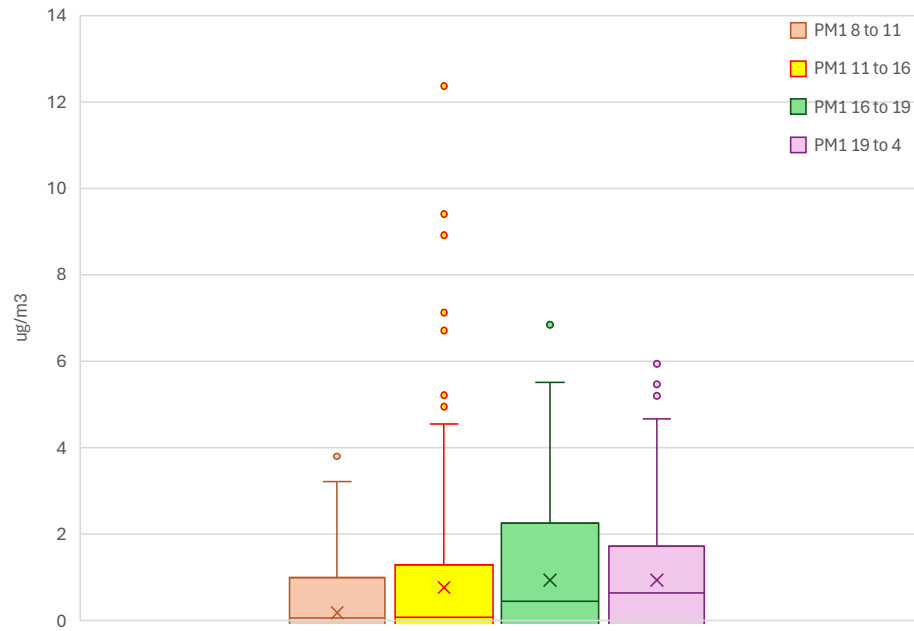

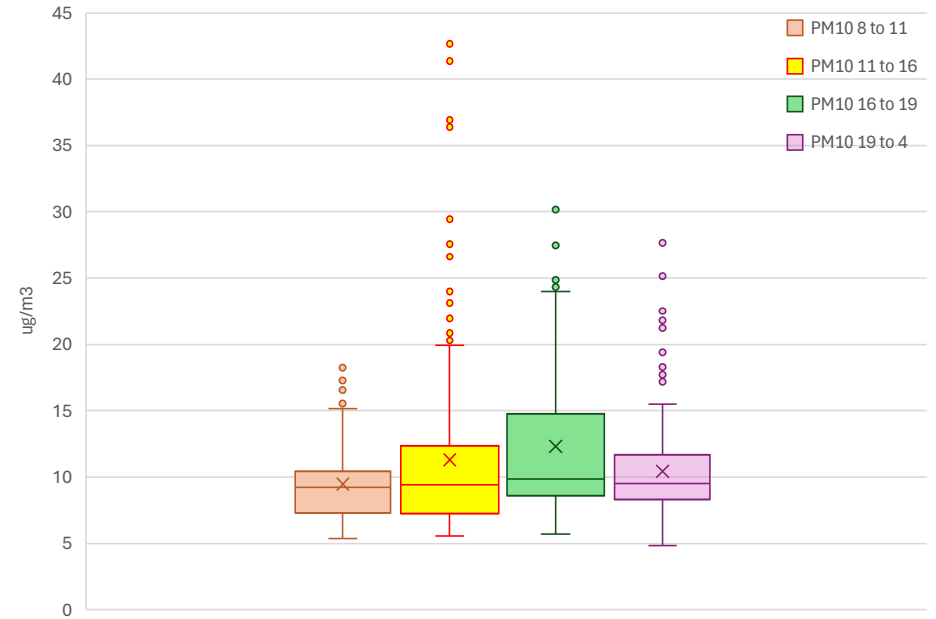

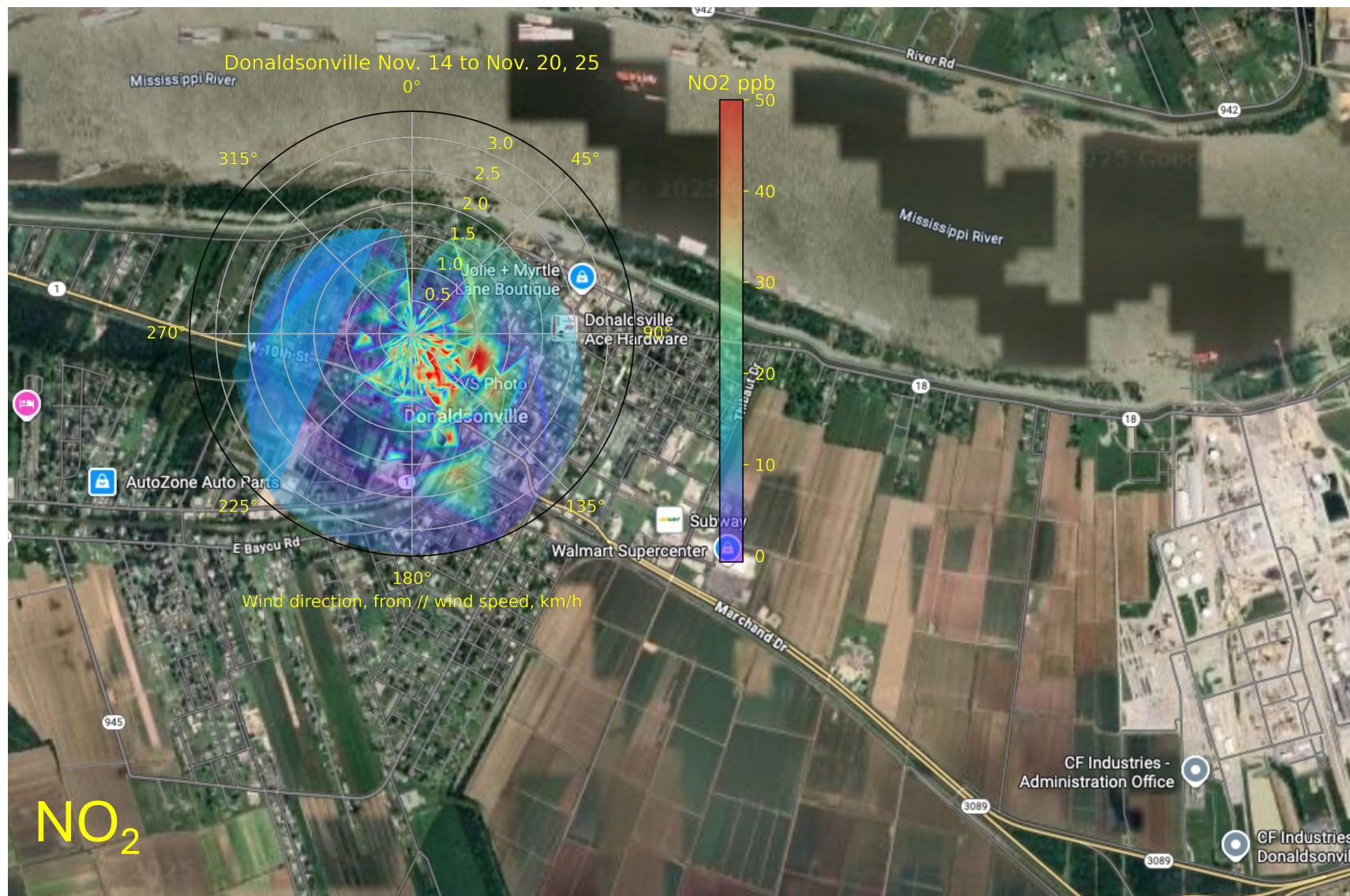
PM10 hourly distribution



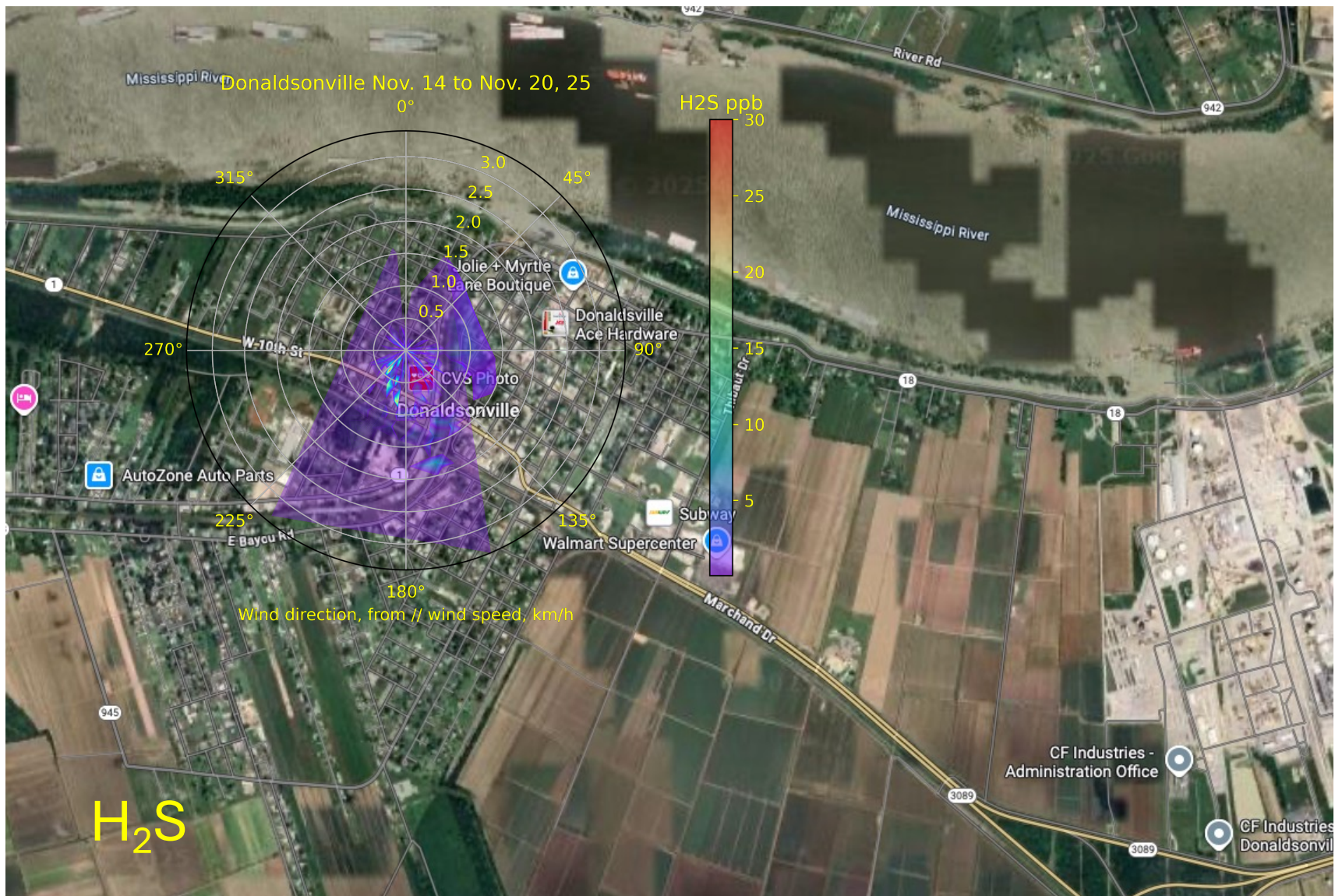

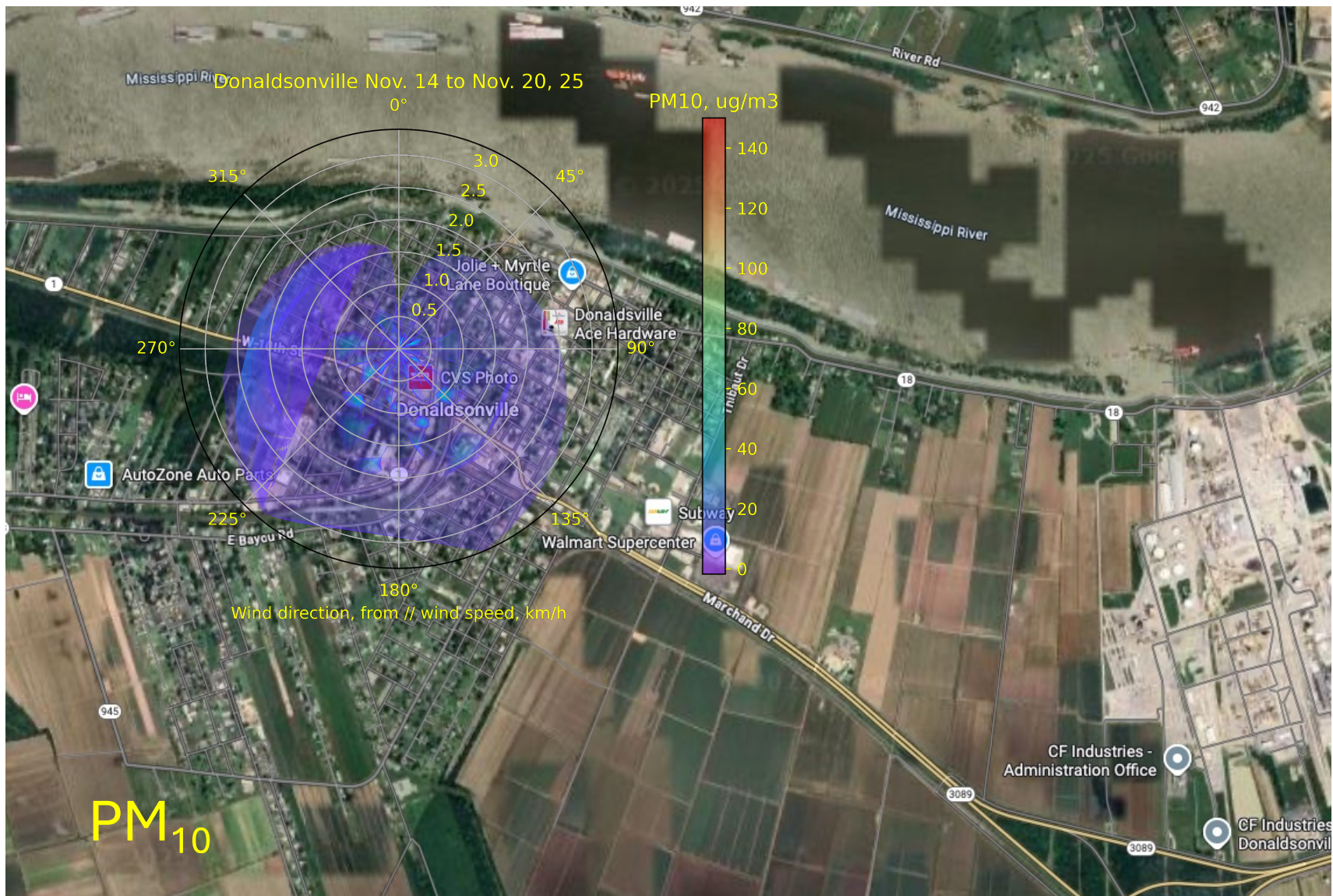














Donaldsonville POD 11/14- 11/20
