



## *Disclaimer*



*At the same time, most of the sensors are subject to QA/QC procedures and are calibrated and evaluated against official regulatory monitors.*




# Hourly concentration distribution

CO hourly distribution










PM2.5 hourly distribution




PM10 hourly distribution



























# St. James POD 12/12-12/18

- Notably high levels of NO<sub>2</sub>, approaching NAAQS annual limits on weekly averages at night. Mostly from South-East direction
- Occasional PM<sub>2.5</sub> also accompanied by high TVOCs from South-West and South-East direction.
