



Disclaimer



Rather, the data is intended for non-regulatory applications -- specifically, to better understand local air quality and to help communities to work with local companies to seek solutions to observed pollution events in a collaborative manner.

At the same time, most of the sensors are subject to QA/QC procedures and are calibrated and evaluated against official regulatory monitors.




Hourly concentration distribution


Hourly concentration distribution






PM2.5 hourly distribution





PM1 hourly distribution




PM10 hourly distribution









St. James POD 12/19-12/25

- Notably high levels of NO_2 , approaching NAAQS annual limits on weekly averages at evening hours, Mostly from South-East direction
- Some $\text{PM}_{2.5}$ also accompanied by high TVOCs from North-West direction.
